1247/1 Co-option of Councillors It was decided to defer further discussion to the next meeting.

1247/2 Playing Field Cllr Lancaster reported that the playground contractor has decided to delay construction until the spring as the ground is saturated and unfit to work over. Clerk is awaiting prices from contractors for the access and footpath works.

1247/3 Donation to ADAS It was agreed to make a further donation to ADAS of £100 towards planting of the troughs around the new war memorial.

1247/4 Safety on the A525 Feedback from the Lap Highways Group indicated the in next year's budget allowance has been made to impose a 40 m.p.h. speed limit on the A525 from the end of the 30 m.p.h. on the Woore Road in Audlem to the Woore side of Buerton.

1247/6 Relocation of original War Memorial Clerk confirmed that the new site in the Audlem Burial Ground Chapel had been agreed and that an order to repair and then remount the tablets had been placed on Rogers Masonry. This to be done in the new year.
