### 1560 Public Forum

Concerns raised:-

1560/1 The state of the bridge in Windmill Lane was raised, as it looks as if a mild knock could tip the damaged section into the road . Is a repair scheduled?

1560/2 A drain cover in the A525 opposite Penders End Farm has dropped and looks in danger of collapse.

1560/3 The drains on Windmill Lane adjascent to the bridge (on the twisty bit) still seem to be blocked causing water and mud to build on the carriage way.

#### 1561 Business Matters

1561/1 Neighbourhood Plan

It was decided that BPC should apply for the Communities Grant to progress the work to make a Regulation14 submission. Clerk to get the data together and submit a bid for funding.

1561/2 Defibrillator

After much discussion it was decided to revert to the use of the original enclosure supplied by Community Heartbeat but to mount it on a frame facing the phone box door. Cllr Hassell undertook to get prices for the frame and installation.

1561/3 Playing field railings.

The new railings have been installed and it was agreed that they should remain unpainted. The A525 gateway and remaining original railings in Windmill Lane to be tidied up and painted next spring/summer.

- 1561/4 Village sign refurbishment to be reviewed next year.
- 1561/5 Clerk reported that the state of the footpath along the A525 had been referred to Cheshireeast Highways and they undertook to assess it.
- 1561/6 The map of the proposed speed limits through Buerton was tabled and it was agreed that the proposals were only the minimum that could be achieved. After this the letter from Audlem Parish Council expressing concern over the proposed speed limit and safety upgrades on the A525 was discussed and it was agreed that a letter of endorsing the comments made should be sent to Cheshireeast Highways.
- 1561/7 The Highway Service Satisfaction Survey 2015 as completed by Mike Smith was approved and Mike thanked for his efforts.
