1257 Business Matters

1257/1 Co-option of Councillors It was decided to defer further discussion to the next meeting.

1257/2 Playing Field Date for the start of the construction work for the play equipment is still awaited from the supplier.

Clerk has been in contact with D J Espley who is a RoSPA Safety inspector and obtained a budget cost for the necessary regular inspections.

M K Preece had submitted a quotation for the paths and access works. Clerk to try and get a further quote. It was decided that these works be carried out after the play equipment is installed to avoid damage to paths etc.

1257/3 Footpath Damage. Back Lane. Clerk to progress with CEC Footpaths.

1257/4 Relocation of original War Memorial Rogers confirmed they are ready to start work. Clerk to progress.

1257/5 New War Memorial It was confirmed that the paving around the new war memorial and the existing paving by the seat should be the same and the work added to the contract for the paths and access to the playing field.

1257/7 Railing damage on the A525 Clerk has been in contact with CEC (Mark Bone) who confirmed that due to restricted funding, there is no prospect of replacing the damaged railings in the foreseeable future. Mark confirmed that should the Council so decide, Buerton could repair/replace the railings at their own cost.

1257/8 Snow Clearing Kit This has been collected from CEC and will be held by Cllr Shaw.

1257/9 Community Pride Competition It was agreed that Buerton will not enter this year.
