#### 1316 Public Forum

Residents of School Field Close stated that in their opinion the play equipment newly installed on the playing field is too close to their properties and that they have been disturbed by the noise made by children playing throughout the day. They also raised concerns about supervision of children and adolescents on the playing field and the play equipment. It was also claimed that not enough publicity had been given to the Council's plans and intentions. A request was made to move this equipment further from the boundary with School Field Close.

Councillors pointed out that the decision to put a playground on the playing field had been the Council's policy for at least 5 years and that all discussion and action had been available in the minutes of meetings, which have been displayed on the Council notice board and for the last two years, put up on Audlem-on Line. In addition, progress has been mentioned in the Audlem news letter delivered to all households. Also plans had been tabled at Council meetings and displayed on the Council notice board and Audlem-on-Line and that discussions had taken place both inside and outside of meetings.

It was agreed that if any further development of the play area was planned, residents of School Field Close would be informed so that they could make a contribution at the meetings where this was to be discussed. It was also agreed to put the possibility of erecting some sort of screening for these properties on the next meeting agenda.
