1752/1 Defibrillator

Clerk has confirmed that another set of pads have been purchased.

1752/2 Roads

Cllr A Hassell noted there has been yet another collision on the bad bend outside Buerton Hall Farm and requested that the clerk contact highways about the incorrect position of the 40mph sign which is currently outside Maltkiln Farm, Woore Road.

1752/4 The quotes for new gate and hinges at the A525 entrance to the playing field and the fitting of goal post stanchions to the goal posts were discussed.

1752/5 Pruning of the oak tree is still required. Cllrs decided the preferred option was for Twisted Oak to do a crown reduction, the tree does in fact have a preservation order in place and permission is needed in order to proceed with the work.

1752/7 Cllr Hassell and Cllr Shaw discussed the need to recruit more first responders following an incident whereby a local Buerton resident was displaying all the signs of a stroke/heart attack and it took 2 hrs and 15 minutes from the initial 999 call for the paramedics to attend. There was a first responder on duty at the time but for reasons unknown at this time ambulance control did not page. Luckily Cllr Hassell's wife is a qualified midwife and attended, also although Cllr Shaw was not on call she kindly attended as a qualified first responder. Cllr Hassell discussed joining forces with Audlem and Hankelow parishes and also discussed an article going on Audlem on line to recruit more first responders. Cllr Shaw to follow up with ambulance as to the reasons for the unsatisfactory response time in attending to the casualty.
