4 members of the public were present.

A member of the public stated that they were disappointed that organisation of an annual walk of the parish footpaths was not on the agenda, following on from the discussions at the last council meeting.

There was general discussion regarding poor state of footpaths, a member of the public raised concerns that a stile had been removed from a public footpath was replaced with a fence.
